- Live in contract status making progress. Need to manage expectations with live-ins.

### Tom Dufficy:

- Quote from Bismark for redoing the office area at Station 1, \$65k (heater, cabinets, ceiling, rug, etc.). Will get additional quotes.

- Equipment was not cleaned after use during a drill (saws). Chief will address.
- Will get \$1100 from the State. ERiggs needs to sign paperwork and it needs to be witnessed (ARelkin and TDufficy).
- ERV policy to be signed in January.

### Rich Gregory:

- Productive tri-district meeting. Another meeting coming up. Should come up with an agenda for the meeting.
- Haas System module that goes on the truck: ARelkin says it's not a good option at this time.
- Discussed crash trucks for highway calls, at meeting.

### Ed Riggs:


- Talked to lawyer regarding fire tax r/b. No update yet.
